

## PRIVACY DISCLAIMER for Processing of Personal Data within the Framework of the KLIX Financing Solution

If you decided to buy goods or services in an online store using a loan or take a consumer loan without purchasing a particular item, the KLIX Financing solution will help you choose a lender.

With the help of Klīx Financing you can:

- enter into a consumer loan contract with the lender or loan contract for the performance of commercial activities with the lender (in case this functionality is available in the respective country) in order to pay for selected goods or services in merchants' store.
- enter into a consumer loan contract with the lender without making a particular purchase (in case this functionality is available in the respective country). In this case full loan amount would be transferred to your account.

This Privacy Disclaimer for processing of personal data within the framework of the KLIX Financing solution (hereinafter – the Privacy Disclaimer) contains information on issues related to the processing of your personal data on the KLIX solution, performing remote customer identification, filling in a loan application form, requesting loan offers, and if you are offered a loan, you will receive an offer from financial institutions (lenders), reflecting the lenders' loan offers and providing an opportunity to conclude a loan contract between you and the lender of your choice.

In view of the above, we will process your personal data within the framework of the KLIX Financing solution, and we would like to inform you about it in accordance with the requirements of regulatory enactments on privacy and personal data protection.

### Who will process your personal data?

code from SK ID Solutions AS. In turn, if you use a secure electronic signature during remote customer identification, we will receive your name and surname as well as your personal code from Latvijas Valsts radio un televīzijas centrs VAS.

At the same time, we inform you that lenders may obtain your personal data from other information sources for provision of lending services, about which you can obtain more detailed information in the lenders' privacy policies, privacy notices or other information materials published on lenders' websites. Information on your transactions and information on accounts you have selected in financial institutions we will receive from the Account Information Service Provider.

#### **Whom do we transfer your personal data?**

Processing of your personal data within the framework of the KLIX Financing solution will be ensured by the authorized employees of Citadele banka AS. In turn, in order to provide the lending service itself, your personal data will be transferred to the lenders. While ensuring the operation of the KLIX Financing solution your personal data will not be transferred in any other way.

We provide information to merchants about concluded loans and your personal data to ensure faster goods delivery to you.

#### **How long do we store your personal data?**

In order to ensure that you have the best experience in using the KLIX Financing solution, the personal data submitted by you will be stored on the KLIX platform for 5 years from the moment of submitting the personal data. For the same period, your personal data will be stored in order to protect the legal interests of Citadele banka AS in case of complaints or claims regarding the provision of the KLIX Financing solution. Information on your transactions received from the Account Information Service Provider will be temporarily stored for up to 30 days.
